Data collection

The following categories of personal data are collected by us:

Communication

When you send e-mails or other messages to us, we may save messages. Sometimes we ask you for your personal information for the relevant situation. This makes it possible to process your questions and your respond to requests. The data is stored on secure servers from Hotel Handelia or that of a third party. We will not combine this data with other personal information we have.

Data that we collect automatically

When using our website, we also automatically collect data, including personal data. We can also collect data automatically via cookies.

Cookies

We collect data for research in order to gain a better understanding of our customers, so that we can tailor our services accordingly. This website uses "Cookies" (text files placed on your computer) to help the website analyses how users use the site. The information generated by the cookie about your use of the website can be transferred to secure servers of Hotel Handelia or that of a third party. We use this information to keep track of how you use the website, to compile reports on website activity and others to offer services relating to website activity and internet use.

Purposes

We do not collect or use information for purposes other than:

- A) Reservations: We use your personal data to your online, e-mail or telephone complete and process reservation.
